NEEDLE COTTAGE CULLEN TERMS AND CONDITIONS

- 1) Reservations are normally Saturday to Saturday. Short breaks are available during low season only and are subject to availability.
- 2) No smoking is allowed inside the cottage and any damage or extra cleaning caused by a guest smoking in the cottage will be charged for.
- 3) In order to maintain the cottage to a high standard of cleanliness guests are asked not to arrive before 2.00pm on day of arrival and to depart before 10.00am on day of departure. We would be grateful if guests could leave the cottage clean and tidy.
- 4) Well behaved, fully house trained dogs are welcome. There is a charge of £15.00 per stay per dog and must be declared at the time of booking. All dogs are expected to be flea treated before arrival. Dogs must not be allowed on the furniture or left unattended inside the property at any time. Any extra cleaning required, or damage caused, will be charged for.
- 5) A deposit of £50.00 is payable at the time of booking. Bookings will only be confirmed upon receipt of the completed booking form and deposit. In the event of a booking not being accepted, the deposit will be refunded in full without delay.
- 6) The number of occupants must not exceed the number notified upon the booking. Please contact us before arrival if the number of guests is to change.
- 7) Cancellations must be advised immediately. We will endeavour to secure a successful re-let and any payment already made, less £20.00 expenses, will be returned. If we are unable to re-let the cottage all payments will be forfeited and the amount outstanding must be paid in full.
- 8) Guests are responsible for all the contents of the cottage when hired. Any damage and breakages must be reported and paid for before departure. The hirer is responsible for ensuring that all persons occupying the property, along with any visitors, comply with the terms and conditions.
- 9) The letting is strictly on the basis that the property is for holiday use only and that there is no right to remain in the property after period booked. All persons shall be required to vacate the premises at conclusion of period let.
- 10) Duvets, full bed linen, tea towels and dishcloths are provided. The cost of gas and electricity is included in the hire fee.
- 11) The owners do not accept responsibility for any injury sustained to guests or visitors, or to loss or damage to any property brought onto the premises.
- 12) Please respect our neighbours and do not cause any offence or inconvenience to others.
